Memorandum of Understanding (MOU)

OLD N FURNITURE a proprietorship firm having its registered office at K.P Mondal road, Abhirampur, Purba Para, Budge Budge Kolkata -700137 thereinafter referred to as first party which expression shall unless contrary to and or repugnant to the context means and include its successors represented through SK JIYAUL HAQUE to enter into and this Agreement for and on behalf of the First Party.

AND

Surendranath Evening College. a company incorporated under the companies Act,1956. having its registered office at 24/2, Mahatma Gandhi Road, Kolkata – 700009, there in after referred to as Second Party which expression shall unless contrary to and or repugnant to the context mean and include its successors represented through Dr. Jafor Ali Akhan (Principal) to enter into and sign this agreement for and on behalf of the second Party.

- A.) First Party is a registered E-waste Dismantler vide the Registration No. 03/2S/(HW)/(EW)-3742/2019 dated 28/06/2019 valid up to 31/05/2024 and is authorized to undertake activities prescribed for Producer Responsibility Organization.
- B.) The second Party in compliance of E-Waste Management Rules, 2016 desires to have service for management of their Electronics Waste except liquid waste. Now this Agreement witnesses the following terms & conditions to be performed by both the parties to the agreement.
- 1. The First party has agreed to pick up, transport, carry and recycle/dispose of the E-waste from the Second party as per the norms prescribed by the Government Authorities from time to time.

2. The First Party has agreed to make available utilization Certificate confirming that E-waste provided by the second party has been recycled/disposed of as per the norms prescribed by the Government authorities within 60 days of the E-waste pick up. The second party will sign required documents to acknowledge that E-waste has been handed over to the

First Party. While the first party is under the agreement with the second party, the second party should not have the further communication with the other stake holder or any other company for the same dealings.

- 3. This Agreement will be in force for a period of **3 years** from the date of execution of this Agreement Valid till 9th January, 2026 and can be renewed of the said period by mutual consent.
- 4. The Second Party will accumulate all E-waste and inform to the first party once reasonable volume (approx. 300 kg minimum) has been accumulated. The pickups confirmed by the second Party will be carried out on a priority basis within Five days from the date of request.
- 5. The second party has agreed to hand over the E-waste the details of which are mentioned here below to the first party on as is where is basis.
- 6. The second party's responsibility will cease once electronic waste has been handed over to first party as per clause above. Further no liability would accrue on the second party on account of E-waste.
- 7. The renewal of the contract will at the end of the tenure/period and the documentation formalities shall be done by first party within 30-45 days prior to the date of Agreement termination.
- 8. Records and date of the E-waste material procured will be maintained and transparently shared by the first party.
- 9. The second party agrees that the general waste such as municipal solid waste will not be included in the E-waste.
- 10. Either party can terminate this Agreement by giving 45 days written notice in advance to the other party citing reasonable ground for such action. However, the other party is no entitled to claim any compensation for such premature termination if with reasonable sufficient ground.
